#### Germanium – Potential Contribution to the Kihabe-Nxuu Polymetallic Project

Further to the announcement released to the market on 6 July 2023, outlining a Gallium Exploration Target at the Kihabe Deposit, the Company has received enquiries as to the potential of Germanium. Germanium (Ge) is usually associated with Gallium in what are primarily Zinc deposits.

#### Germanium Assay Results from the Kihabe-Nxuu Project

Assaying for Ge was conducted on samples from drilling at the Kihabe and Nxuu deposits in 2017 and on samples from further drilling conducted at the Nxuu deposit in 2021.

#### **Nxuu Deposit**

Twenty-eight of the fifty-two holes drilled into the main zone of the Nxuu Deposit have been assayed for Ge. (Refer to Figure 1)

Ge results have all previously been released to the market. However, Ge results announced from 2017 drilling were based on applying a 5g/t low cut grade. Results from 2021 drilling were based on applying a 3g/t low cut grade. With the increased Ge price all results are now based on applying a 3g/t low cut grade and are summarised in Table 1.

The average 43.5% of drill hole lengths in quartz wacke containing Ge mineralisation of 4.2g/t is made up of varying ranges within the 28 holes. These range from 3m (6%) in NXDD047 on Section 14 to 37.58m (100%) in NXDD030 on Section 15.

Figures 2 to 4 show high percentages of Ge mineralised lengths:

NXDD030 on Section 15 - 100% over 37.5m @ 4.8g/t NXDD098 on Section 18 - 34m (94.4%) over 36.0m @3.6g/t NXDD029 on Section 22 - 35.5m (98.3%) over 36.08m @ 4.6g/t

The average 43.5% of drill hole lengths in the Quartz Wacke @ 4.2g/t Ge together with Zn/Pb/Ag/V2O5/Ga could represent a significant credit for the totally oxidised shallow basin shaped Nxuu Deposit, where the average depth to base of mineralisation is only 42.15m.

Upon completion of revisions to Figures to show the Ge intersections for all holes listed in Table 1 showing Ge grades based on the low cut of 3 g/t for Ge alongside Zn/Pb/Ag/V2O5/Ga, data will be released to the market.

# **Kihabe Deposit**

Only seven of the 143 holes drilled into the 2.4km long Kihabe Deposit, situated 7km West of the Nxuu Deposit, were assayed for Ge in 2017. Six of these contained Ge, results from which have previously been announced to the market, based on applying a 5g/t low cut grade. With the increase in Ge price results are now based on applying a 3g/t low cut grade and are summarised in Table 2.

# Table 2 shows the averages for 6 holes drilled only to the base of oxidation, as follows:

#### An average of 42.1% of drill hole lengths within the upper oxidised Quartz Wacke, contain Ge at 4.6g/t.

Whilst limited assaying has been conducted for Ge at the Kihabe Deposit, based on 42.1% of drill hole lengths containing Ge at 4.6g/t, indications are it could represent a significant credit for the Kihabe Deposit.

## Mineralogical test work conducted on Germanium

University of Tasmania has confirmed that Ge/Ga are hosted in micas which can produce high percentage float concentrates. However, the host minerals still need to be determined through additional mineralogical evaluation. Once the Ge/Ga host minerals have been confirmed, metallurgical test work is required to confirm processes required for on-site metal recoveries. Composited metallurgical test work is required to determine the order in which each individual metal's on-site recovery process should be applied. This is in order not to deteriorate each individual metal's known on-site recovery process and recovery rate (ie: 93% Zn can be recovered through SX/EW. 82% V<sub>2</sub>O5 can be recovered through gravity separation, followed by subjecting the tail to flotation using hydroximate acid for recovery).


**NXUU DEPOSIT SECTION 15** 




# **NXUU DEPOSIT SECTION 18**


